1. Market participants are referred to Chapter 12 of the Botswana Stock Exchange Limited (BSEL) Equity Listings Requirements (the Requirements), which sets out the eligibility and continuing obligations for BSEL Registered Advisers.
2. The BSEL advises all market participants that with effect from **1 January 2019**, listed companies and applicants to the BSEL are expected to obtain advisory and related professional services only from Advisers approved by the BSEL and recorded on the BSEL List of Registered Advisers. Please refer to **Annexure A** attached herein for the up-to-date BSEL List of Registered Advisers.
