1. The BSE wishes to inform the market that it is in receipt of a Circular Savingram from the Botswana Government (refer to **Annexure**), which indicates that **Monday 3<sup>rd</sup> July 2023** will be observed as a Public Holiday since 1<sup>st</sup> July is a paid Public Holiday in Botswana.
2. For this reason, the market is advised that the BSE will also be closed for trading on **Monday 3<sup>rd</sup> July 2023** day.
3. Trading will therefore resume on Tuesday 4<sup>th</sup> July 2023.

### **MONDAY 3<sup>RD</sup> JULY 2023 TO BE OBSERVED AS A PUBLIC HOLIDAY**

Addressees are hereby informed that **Monday 3<sup>rd</sup> July, 2023** will be observed as a public holiday in the Public Service.



This is in line with the provisions of Section 99 (2) of the Employment Act [CAP. 47:01] read with Section 2 (1) of the Public Holidays Act [CAP. 03:07] together with Regulations 11 (1) and (2) of the Public Service Regulations, 2011 which provides that;

**“(2) where a paid public holiday falls on a rest day, the day next following the rest day, which is not itself a rest day, shall be deemed to be a public holiday”.**

Consequently, since Sir Seretse Khama Day (1<sup>st</sup> July 2023) is a paid public holiday which falls on a rest day (Saturday), Monday 3<sup>rd</sup> July, 2023 shall be observed as a public holiday in the Public Service.
